New Build - Project Notification Form (PNF)

Insurance Cover Provided

Building Warranty Insurance covers the cost to repair damage in new buildings for 10 years from the date of practical completion of the project which has been caused by defective design, faulty materials or defective workmanship. In some cases cover is also provided for losses due to the failure of the builder to complete the project. The Policy is issued by Stamford Insurance acting as the Scheme Administrator on behalf of certain underwriters at Lloyd's of London. Our policies protect the owner and their tenants and can be assigned to subsequent owners on sale.

Stamford Builder / Developer Registration

A warranty can be issued where the Builder / Developer has been approved by Stamford. To become approved please complete a Builder / Developer Registration Form. If the form is fully completed and submitted with all relevant up to date information, we would expect to confirm our decision within 10 working days.

Project Notification (to obtain quotation)

Once the Builder / Developer has been approved, a Project Notification Form should be completed for each project.

Duty of Disclosure

It is a basic principle of Insurance Law that when applying for insurance, you must disclose any material facts to the insurer and the answers you give must be true and complete. A fact is material if it would influence the insurer in deciding whether or not to accept an application for insurance and if so, on what terms. You cannot disclose information which you do not know and you do not have to disclose information:

- which diminishes the risk being considered by the insurer
- which is of common knowledge
- which the insurer knows or ought to know in the ordinary course of business
- where your duty to disclose is waived by the insurer

If you are in doubt about whether a fact is material or not, you should disclose it.

Privacy Statement
